CALL TO ORDER

Mr. Mark S. Lawrence, Rector, formally called the meeting to order at 8 a.m. in the President's Conference Room, Third Floor, Martin Hall, Radford University, Radford, Virginia.

APPROVAL OF AGENDA

Rector Lawrence asked for a motion to approve the February 16, 2018 agenda. Mr. Robert A. Archer so moved and Mr. Randy Marcus seconded. The agenda was approved unanimously, as published.

APPROVAL OF MINUTES

Rector Lawrence asked for a motion to approve the December 8, 2018 minutes for the Executive Committee. Mr. Marcus so moved and Mr. Archer seconded. The minutes were unanimously approved.

PRESIDENT'S REMARKS

President Brian O. Hemphill provided updates on recent campus activities. He began by sharing news regarding the intended merger with Jefferson College of Health Sciences. Leading up to and following the January 18, 2018 announcement, there has been extensive coverage of the merger, which has generated a great deal of positive feedback about the future. The team is quickly moving from the announcement phase to the implementation phase of the merger.

President Hemphill provided updates on his meetings with various state officials building support for the new academic building, the Center for Adaptive Innovation and Creativity, which will serve as the new home to the College of Visual and Performing Arts with additional space for the Waldron College of Health and Human Services. President Hemphill also announced that the University will host an event on March 14, 2018 to dedicate and name the IMPACT Lab, which was created nearly a year ago to implement a competency-based education strategy and subsequent programming

OVERVIEW OF BOARD COMMITTEE STRUCTURE

Vice Rector Marcus distributed information related to Committee structures of Board of Visitors within the Commonwealth of Virginia and peer institutions. Additionally, he shared information regarding how the current Committee structure aligns with the recently approved strategic plan. A copy is attached hereto as *Attachment A* and is made a part hereof. Following discussion, the Committee agreed that the current structure allows the University to move forward in meeting the goals and strategies outlined in the strategic plan. The Committee discussed the possibility of several minor updates to Committee names moving forward. For example, there was discussion and consensus for moving the Student Affairs Committee to the Student Success Committee and the Academic Affairs Committee to the Academic Excellence Committee. Additionally, there was some discussion regarding the scope of the Governance, Administration and Athletics Committee.
