Whereas: The current pandemic outbreak of COVID-19 threatens Radford University's students, staff, and faculty with possible extreme harm. Radford University must act decisively and expeditiously, as a united community, to preserve the work of education and service to which its people and resources are dedicated; and

Whereas: The June 12, 2020, Radford University Board of Visitors budget resolution that suspended handbook protections related to appeals, grievance, and reduction of workforce owing to financial exigency (sections 1.8, 1.9, 1.15 and 1.16) constitutes a weakening of the principles of cooperative leadership and due process that guide the institution. These principles of due process, articulated in the *Radford University Teaching & Research Faculty Handbook*, serve a critical role in the function of the American university system. Moreover, due process is a fundamental protection for employees in many types of institutions, not just higher education, and is foundational to what it means to live in a democratic nation; and

Whereas: These suspensions of cooperative leadership and due process have been noticed by our students, our surrounding community, and our colleagues and peers. The Virginia Conference of the American Association of University Professors, the Faculty Senate of Virginia, and the Faculty of the Mary Washington University have all publicly voiced emphatic criticism of the Board's resolution because it violates the principles of shared governance and due process, bringing negative attention upon the University at a time of enrollment challenges and financial crisis; and

Whereas: The Board of Visitors has not declared a state of fiscal exigency, yet has vested the authority in the President to act as though it has, while vacating all processes that guarantee inclusive decision-making, fairness, equity, and due process in a time of financial crisis; and

Whereas: Through this resolution the Board of Visitors bypasses cooperation and collaboration by preventing selection of faculty representatives elected explicitly for the purpose of developing a budget reduction strategy thereby allowing for the dismissal of faculty members outside the processes of fairness and cooperation elaborated in the Faculty Handbook;

Option A, or the across the board method, appears equitable but it would disproportionately affect those lower on the pay scale and departments with limited budgets. Option B puts forth strategic reductions in consultation with leadership councils from faculty, staff, and administration but does so outside of the *Teaching and Research Handbook*. The justification of developing a process outside of the handbook is limited time and the need for rapid action. We are prepared to elect faculty to an ad hoc committee and act quickly in full collaboration with the administration and Board of Visitors.

Students who have completed of a VCCS Transferable Associate Degree (see additional information within the Radford University Transfer Guide) will satisfy all requirements for the REAL Curriculum.

Students who have not completed one of these approved transfer associate degrees but have at least 60 approved transfer credit hours and at least 3 credit hours in each of the REAL areas (R, E, A, and L) are only required to complete a major, minor or certificate that fulfills at least one area of the REAL Curriculum. If transfer students are missing any of the 3-credit hour coursework in the REAL areas, those courses may be taken at Radford University to fulfill the REAL Curriculum general education requirements. **This only applies to students who transfer in at least 60 approved transfer credit hours.**

Students with fewer than 60 approved transfer credits may be able to apply these credits to majors, minors, and certificates to fill the REAL Curriculum. Courses transferring into Radford University will be given the REAL designations of the approved equivalent courses. For example, students who transfer in a course offered at Radford University that has an E and Writing Intensive designations will result in that student applying those elements of the REAL Curriculum upon transfer. The same is true for all REAL areas, foundational writing and math, and cornerstone personal/professional development, and writing intensive designations.

If a student transfers in a course that does not have a course equivalent at Radford University, the application of the course to the REAL requirements (REAL area, foundational writing or math, or cornerstone personal/professional development and writing intensive) will follow the standard procedures for seeking transfer course designations. These are evaluated by the REAL Council and the Executive Director for General Education in consultation with discipline area chairs and school/department directors. Department chairs and School Directors ultimately determine if a course counts towards their discipline(s) and major(s). Additional documentation of the course content may be needed to complete the transfer course evaluation.

 - a) Academic Excellence and Research Goal 4, “Radford University will increase faculty and student-faculty collaborative research, scholarship, and creative activities that are externally validated through peer review and supported by grants”;
 - b) Economic and Community Development Goal 1.A.2, to “provide technical assistance and research expertise to local and regional governments and to economic development groups and alliances”; and
 - b) Student Success Goal 1.A, to “increase the number of students engaged with research, scholarship, and creative activities within and beyond the classroom.”
- 2) Refer to the motion in *Appendix B*, approved by the BOV in 2013, based on the recommendation of the Virginia Office of the Attorney General. That motion removed Section 3.1 of the Radford University Teaching and Research Faculty Handbook, which limited faculty compensation:

“The maximum earnings for full-time faculty from all Radford University employment, including other Radford University assignments, grants, overloads, and Radford University summer employment, shall not exceed 133% of the faculty member's base academic year salary.”

In addition, because federal regulations under the Uniform Guidance Policy (Appendix C) apply to federally funded grants only, and explicitly define different compensation situations, therefore requiring faculty consultation with HR before policy implementation or contractual obligations will support Radford University's regulatory compliance. The regulations also suggest how a university-wide policy, could be drafted in a way that promotes research (one

of the pillars of the Radford University's fundraising campaign), and innovation; or without due diligence, can slow research, hinder innovation and reduce revenue.

“A course number indicates – in a general way – the difficulty and level of the student group for which the course is offered. Courses numbered 100 to 199 are primarily for freshmen; 200 to 299 for sophomores; 300 to 499 for juniors and seniors; 500 to 799 for juniors, seniors and graduate students. Students must attain sophomore standing (26 semester hours) before enrolling in any 300/400-level course.”

Insert the following language at the end of the paragraph, “This rule does not apply to courses designated as General Education (GE).”

RATIONALE:

Courses designated GE must be open to all students. So, this change simply removes a contradiction from the catalog by making an exception to the policy that sophomore standing is required to register for upper-level courses in the case of courses designated GE. Such exceptions are currently being routinely made. The number of upper-division courses designated GE is few. Departments that sought GE designations for courses are aware that GE-designated courses must be open to all students.

20-21.154: Motion to Require Credit Hours Outside First Major Department/School

Referred by: Curriculum Committee

MOTION:

Faculty Senate recommends addition of the following language to the academic catalog section entitled REAL Curriculum:

In addition to all other requirements, in order to fulfill the REAL Curriculum, students must complete at least **15 credit hours**, not including foundational math and foundational writing, in courses taught outside the departments or schools that house their first majors.

RATIONALE:

- A rule requiring credits outside the home department or school is necessary to ensure that the REAL curriculum has breadth given that many departments have proven able to cover nearly the entire REAL curriculum with their own coursework.
- Setting the bar at 15 makes this rule equivalent to the minimum amount of coursework for a minor. A goal of REAL was that every student would have, in addition to their major, at least a minor, which the university catalog describes as a degree program different from their major.
- REAL Council does not want to limit the ability of students to have any combination of majors and minors.
- This condition can be fulfilled with transfer credits.

20-21.156: Motion to Recommend Separation of the School of Nursing from Waldron College as a Stand-Alone Academic Unit

Referred by: Senators Dr. Katie Katz and Dr. Sarah Gilbert

MOTION:

Faculty Senate recommends that the School of Nursing separate from Waldron College to form a stand-alone academic unit, **providing it is a budget neutral decision**

RATIONALE:

The proposed organizational change is necessary because of the following: the increased complexity in function and governance of the Radford University School of Nursing post-merger, as well as the increased number and size of academic programs.

Complexity

The Radford University School of Nursing is currently too large and complex to function as a college department or school within another academic unit (Waldron College of Health and Human Services). The undergraduate and graduate nursing programs require accreditation by multiple state and national organizations. accreditations of degree programs, concentrations, and the simulation centers. Radford University School of Nursing's current structure requires that all the functions (admissions, progressions, graduations, curriculum, etc.) for each degree program and concentration to be ratified at the degree level, the school level, and the college level. These duplicative functions are increasingly complex to manage across multiple instructional sites. The proposed change would streamline the function of the Radford University School of Nursing and improve the responsiveness to the dynamic nature of the healthcare industry needs related to nursing education.

Size

With the Jefferson College and Radford University merger, undergraduate nursing enrollment in the Radford University School of Nursing increased by 268.4 percent while graduate nursing enrollment at Radford University School of Nursing increased by 281.6 percent. In 2018, 234 undergraduate nursing students and 38 graduate nursing students were enrolled in Radford University School of Nursing. In 2019, 628 undergraduate nursing students and 107 graduate nursing students were enrolled in Radford University School of Nursing. The Radford University School of Nursing now includes 60 full-time faculty, 41 adjunct faculty, and 5 full-time staff. The current Radford University School of Nursing student body and faculty size is more comparable to the other departments in the Waldron College of Health and Human Services departments combined as well as to the Artis College of Science and Technology and the College of Humanities and Behavioral Sciences.

Academic Programs in Radford University School of Nursing

At Radford University most departments have only one or possibly two degree programs (if a masters is offered) so three degree programs with three undergraduate tracks and four graduate concentration tracks is a large number of offerings for an academic unit that is not independent. The best option for addressing the large enrollment, faculty, and increasing complexity resulting from managing the mix of three degree program levels and multiple concentrations and maintaining compliance with the Virginia Board of Nursing is to create departments within the Radford University School of Nursing based on instructional sites. for SON separation from Waldron College

The proposed organizational change is necessary because of the following: the increased complexity in function and governance of the Radford University School of Nursing post-merger, as well as the increased number and size of academic programs.

20-21.157: Motion to Recommend Approval of the Course Minimums Policy

Referred by: Faculty Senate Executive Council

MOTION:

Faculty Senate recommends the approval of the Course Minimums policy.

RATIONALE:

The ad hoc Course Minimums and Faculty Workload Committee was charged with drafting recommendations related to course minimums. Specifically, the Provost charged the committee with recommending 1) benchmark course minimums, 2) exemptions to the course minimums, and 3) a process for applying the exemptions.

While individual department chairs have worked with deans, Radford University has not had a consistent, transparent policy or process related to course minimums. The Course Minimum policy is a proactive and strategic measure to reducing the number of under-enrolled courses at Radford University, which can result in significant savings to Academic Affairs.

The course minimums benchmarks are consistent with policies from other universities. The exemptions and exclusions provide flexibility as departments have different scheduling needs and constraints.

The draft of this policy went through iterative rounds of feedback with the chairs, deans, and Provost. The policy would be piloted in the Fall 2021 to allow for collecting course information and piloting the process without requiring course cancellations. This pilot period would also for departments to reclassify courses as needed. Adjustments to the policy may be made prior to full implementation based on input from chairs and deans. A full review of the policy would take place in spring of 2023.

20-21.158: Motion for Formation of an Internal Governance Committee on Online Education

Referred by: Faculty Issues Committee

MOTION:

The Faculty Senate recommends the formation of an Internal Governance Committee on Online Education.

Function and Overview of committee responsibilities: This committee will monitor and guide the policies and practices associated with online and hybrid education by taking the lead in developing and disseminating university-wide policies that can guide further development in this area. All policies proposed by this committee will be approved by the Faculty Senate.

The following list includes the focus and tasks for this IG:

- A community of practice for faculty collaborations involved in sustainable online course development with the potential to accommodate changing demographic needs, which highlights faculty distinctiveness rather than a reliance on third-party content providers.
- Relevant issues for this committee will include legal code compliance (e.g., copyright and FERPA), intellectual property ownership and transfer, online course development and quality assurance.
- A faculty-driven committee that can collaborate with the administration on online programming and the university's general strategy for online offerings.
- A committee that can coordinate online education-related communication and policy follow-through with various offices and departments and existing or new policies on work load.
- A committee that can update the language in the Teaching & Research Handbook so that the guidelines will apply equally well for face-to-face as well as online education.
- A committee that can coordinate and assess faculty satisfaction with the reliability and usability of instructional tools and platforms, such as D2L.
- A committee that can provide assurance that online courses and programs are fully accessible to those individuals using adaptive technologies.

Membership Composition: This committee should consist of six T&R faculty, one from each college elected for a 2-year term; one representative each from the Graduate College, McConnell Library, the Center for Accessibility Services, the Center for Instructional Technology and Learning (CITL), Center for Diversity and Inclusion appointed or elected by the respective unit; and one academic chair and one dean, appointed by the Provost. At least one of the representatives should be chosen to represent RUC. Half of the first group of members will be appointed for 1-year terms in order to create a staggered turn-over of members.

Designated Administrator: Provost.

RATIONALE:

In the past decade, higher education has seen the increasing use of online and hybrid forms of teaching in all disciplines. Although the decisions to move in this direction have been made in response to a variety of factors (the student population, the Covid-19 pandemic, cost control and other factors), they have not always been made in consultation with the faculty who will be responsible for enacting these changes. This motion recommends the creation of an Internal Governance Committee on Online Education to promote a public and sustainable university-wide conversation about differences, similarities, and demands that accompany online education, giving faculty a strategic role in responding to the many issues created by a move, no matter how small or large, toward online education.

The need for this policy is evident: The recent pandemic necessitated substantial changes that were made in a short time-frame and without substantial involvement from faculty prior to implementation. Without university-wide conversations that explicitly afford spaces for faculty-to-faculty and faculty-to-administration discussions about technologies, technology initiatives, and technology-driven policies we may unintentionally:

- Exacerbate fears, concerns, and misinformation among faculty regarding technology-relevant issues, policies, and initiatives.
- Inhibit faculty innovation and receptivity to the university's technology-relevant goals, policies, and initiatives.
- Impede the university's ability to build the necessary capacity and utilize faculty talent and expertise to proactively respond to these on-going changes.
- Overlook the implications of these changes for faculty-recruitment goals

MOTION:

The Faculty Senate recommends that the university support Asian and Asian American and Pacific Islander (AAPI) students, faculty and staff by issuing a resolution against violence and racism against Asians and AAPIs. The university may show its support by issuing its own resolution and/or by supporting the Faculty Senate of Virginia's Resolution of the Faculty Senate of Virginia' on Violence and Racism against Asians and Asian Americans and Pacific Islanders.

RATIONALE:

Violence and acts of racism towards Asians and AAPIs have increased in recent months. The shootings on March 16, 2021 in the metropolitan area of Atlanta, GA, where six out of the eight killed were Asian or AAPI women, demonstrated a need for greater measures to combat racism of all forms against Asian and AAPI communities. The Faculty Senate of Virginia has written a resolution calling on the State Council of Higher Education for Virginia (SCHEV) "to endorse the American Council of Learned Societies' call for 'educators, lawmakers, and community leaders to take this moment to listen closely to Asian and Asian-American voices and work with them in stemming this latest scourge of prejudice and violence.'" Radford University is in the process of adopting a Diversity, Equity, and Inclusion Action Plan that includes, among many short- and long-term actionable items, the *immediate* adoption of a Diversity, Equity, & Inclusion (DEI) Statement. That statement reads, in part, "We understand inclusion to mean embracing and honoring diversity and protecting vulnerable members of our community." In the spirit of our DEI action plan and DEI statement, and in response to recent events, we feel a direct statement in support of Asians and AAPIs both on and beyond campus is needed.

20-21.166: Motion Regarding Adjunct Faculty Compensation

Referred by: Senator William Taggart; Senator David Beach; Senator Geoffrey Pollick

MOTION:

The Faculty Senate recommends to the administration that there be a rationalization of adjunct faculty wages for the 2021-2022 academic year by a) taking into consideration annual CUPA surveys regarding compensation for adjunct faculty; and b) noting what Radford University's peer institutions and local competitor institutions pay for faculty adjuncts in specific disciplines.

The Faculty Senate further recommends that the administration adjust adjunct faculty compensation for inflation that has occurred over the past decade as indicated by the increase in the Consumer Price Index in the Annual Economic Report of the President.

The Faculty Senate also recommends that adjunct faculty compensation be adjusted according to these or similar external measures on an at least a biennial cycle.

RATIONALE:

While adjunct faculty play an important instructional role on campus, wage rates for adjunct faculty have not been revised in more than a decade. Many departments rely on the availability of adjunct faculty to teach a wide variety of courses. Adjunct faculty also provide flexibility to Department Chairs in scheduling of classes and to the administration in handling budget-related contingencies. Adjunct faculty should be compensated at levels that reflect the value they contribute to Radford University. Adjunct faculty wage rates at many of Radford's peer institutions are significantly higher. According to the AAUP's Annual Report on the Economic Status of the Profession, 2019-2020, at Radford's peer institutions for which there is data (Monmouth University, Salisbury University, and the University of Northern Colorado) average compensation per course for part-time faculty was \$974 more than for adjunct faculty at Radford (\$3,982 vs. \$3,008.) In addition, higher wage rates for faculty adjuncts at local institutions make it difficult for Radford to hire and retain qualified part-time faculty. In 2018, the Faculty Senate passed Motion 17-18.36, that called on the administration to raise adjunct salaries. However, no subsequent action was taken by the administration on this issue. This motion seeks to readdress this long-standing problem by recommending that the administration implement inflation-adjusted pay increases for adjunct faculty for the 2021-2022 academic year. The motion also recommends reevaluating adjunct faculty pay periodically to account for ongoing cost-of-living increases.
